



TRIP REGISTRATION FORM

AND GENERAL TERMS AND CONDITIONS OF HIGHLAND ASIA TRAVEL, INC. DBA FAR & HIGH ADVENTURE TRAVEL

All the pages of this form must be read, completed, signed and returned as soon as possible in order to secure your space, even if you have already charged your deposit by phone or online. If you are mailing this form, your deposit of \$ 300 per person is due with this application. Each trip participants must fill up a separate application. If necessary, please photocopy application and use additional pages if needed.

PAYMENT SCHEDULE & METHODS

Tour Deposit: US\$ 300

Final Payment: The balance and final payment is due 90 days prior departure. If your trip involves internal air or train tickets, we may also request the cost of the tickets with booking deposit to guarantee the lowest fare. Credit card payment attracts additional 3.5% fee. We accept the payment from traveler's account only. However, we reserve the right to refuse certain form of payment. Wire transfer fees are to be borne by the traveler.

CANCELLATION AND REFUND

180 days prior departure: No penalty.

90 days prior departure, US\$ 150 per person administration fee.

60-89 days prior departure: US\$ 300 or 25% of the land cost whichever is higher.

45 -59 days prior departure: US\$ 450 or 50% of the land cost whichever is higher.

30-44 days prior departure US\$ 600 or 75% of the land cost whichever is higher.

Within 30 days prior departure: 100%

Cancellation and refund of air tickets cost will be as per rules and regulations of the concerned airlines plus a service charge of US\$ 25 per segment will be levied. Cancellation terms and conditions of certain services may vary which will be informed per case to case basis.

No refund or adjustment to other services will be made for any unused land or air services for any reason whatsoever, once tour begins. We highly recommend that all travelers purchase trip cancellation insurance.

Highland Asia Travel, Inc dba Far & High Adventure Travel (hence forth written as Far & High only), reserves the right to cancel any trip prior to departure for any reason whatsoever, including insufficient sign-up or logistical problems that may impede trip operations. We also reserve the right to refuse your participation on the tour with or without any reason. So, please do not purchase your international airfare until your participation on tour is confirmed by us.

If a trip is canceled due to force majeure (acts of God, war, labor strikes, earthquake, flooding, government rules etc.), Far & High will promptly refund the portion of the trip cost not already advanced to suppliers and use its best efforts to recover and refund the balance as promptly as possible. However, Far & High does not guarantee recovery of any or all of the advance payments made, and our use of best efforts to recover these payments will not include the institution of any legal proceedings in foreign jurisdictions. Far & High. is not responsible for expenses incurred by trip members in preparing for a canceled trip (e.g., non refundable advance purchase air tickets, visa fees, inoculations, equipment, etc.) or for any additional arrangements should the trip member have embarked prior to the scheduled group departure date. Travel insurance fee, visa fee, and visa handling fee are non-refundable. Since most airline tickets are discounted, refund may be subject to penalty from supplier/airline, may not be in full face value, and may require prepayment of processing fee to Far & High.

TRIP MEMBER RESPONSIBILITIES

Trip members have the responsibility to select a trip an appropriate to their

abilities and interests. Trip members are held responsible for being in insufficient good health to undertake the trip. Trip members are responsible for preparing for the trip by studying the itinerary and pre-departure information packets sent by Far & High. and for bringing the appropriate clothing and equipment as advised therein. Trip members may be asked to present physical report or doctor's recommendation for certain trips. Trip members are expected to treat each other and staff respectfully and equally, regardless of gender, race, religion, culture, sexual orientation, socioeconomic status or nationality. Drinking and smoking while in the tour vehicle is strictly prohibited. If a trip member is found physically or mentally unfit, or exhibits a disorderly conduct and the guide determines that his or her continuation on the trip seriously affects the tour, we reserve the right to remove him/her from the tour at his/her own expense and we will not be liable for the refund of the tour payment. Trip members are also responsible to determine their eligibility for visa and travel permits to the destinations you are traveling to. We will not be held liable for denial of your visa and travel permits.

LIMITATIONS OF LIABILITY

Trip participant acknowledges that the nature of tours may involve a significant amount of risk to his or her health and safety. The trip participant hereby assumes all such risk and does hereby release Far & High, its ground suppliers, agents and guides from all claims and causes of action arising from any damages or injuries or death resulting from these risks inherent in travel, visiting foreign destinations, and participating in adventurous activities such as those included in our tour itineraries.

In many cases, suppliers of tour services are independent contractors which include independent ground operators, hotels, transportation companies, airlines, and other suppliers. Because we do not own, operate, manage, control, or supervise these entities, we cannot be held liable for any acts or omissions on their part. Without limitation, Far & High is not responsible for acts of God, accident, equipment failures, vehicle accidents, illness from food or otherwise, detention, assaults, theft or criminal activity, annoyance, delays, quarantine, strikes, accident, civil disturbances, terrorism, government restrictions or regulations, and discrepancies or changes in transit or hotel services over which it has no control.

Reasonable changes in the itinerary may be made where deemed advisable for the comfort and well being of the passengers. The right is reserved to substitute hotels, alter the itinerary, and reverse the order of places to be visited. You will be informed of any necessary changes in a timely fashion.

We reserve the right to change the terms and conditions of the tour any time. Please, do visit our website for an updated terms and conditions.
